A Will to Love: Tracing My Family History

In the past year I've taken a long journey, nearly 170 years in the making, to discover my family's heritage. The key to my ancestry was contained in one simple document: a will. My family's story is made all the more interesting to me because of my line of work, and it involves many of the legal issues relevant to trust and estate law today.

Growing up in Chicago, I knew that my family had settled in Illinois in the 1840s. My great- great-gre

white farmer near present-day Jacksonville, FL. He died in 1846, leaving a will designating that his personal property- livestock, horses, farming tools and household furniture-all be sold to fund the relocation of his slaves to a free state. He assigned a trustee, William Adams, to ensure that his "mulatto slave Lucie," her eight children and six grandchildren, would be moved "to





the states of Illinois, Indiana, Ohio, or a foreign country where they and their children could live free forever."

My family knew that we were descendants of a white farmer and his slave. What we did not know was whether John and Lucie's family was born out of genuine love or something more sinister.
